Fee Policy

- Fee structures will be provided in an itemized invoice. Once agreed you enter into a financial agreement with the nursery to make all payments in good faith.
- You will be required to make this payment directly to our bank via a standing order.
- Nursery fees are payable a month in advance, on the first of each consecutive month. Non payments could result in your child's sessions being withdrawn.
- We accept both the 15hrs and 30hr funding entitlements and also welcome families in receipt of disadvantage 2yr old funding.
- Where funded sessions apply parents will be required to pay additional charges, details of these can be found on your itemized invoice.
- The nursery offers a limited number of free sessions, where these are used parents will be required to pay or provide the itemized consumables that are not covered by the free offer. This will be agreed by all parties in advance of your child up taking their sessions.
- When fee increases are made you will be given adequate notice to amend your payments. When you make your first payment, the contractual agreement is renewed.
- All holidays and sickness are to be paid for in full.
